## Exploring for the wind

Epuron is an Australian-owned renewable energy company, based in Sydney. We are exploring an area east of Muswellbrook that we believe has a good chance of being suitable for a wind farm. This is because:

- There is a good wind resource – we are conducting monitoring to confirm this
- It is in close proximity to the existing high voltage transmission network
- New generation will be required to replace the electricity currently produced by the retiring Liddell Power Station – this project could contribute to that requirement.

## What are the steps in developing a wind energy project?

If the monitoring and testing confirms there is a wind resource suitable for a wind farm and agreement can be reached with landowners, Epuron would seek Development Consent from the NSW Department of Planning & Environment. The project would be subject to a rigorous planning assessment as a State Significant Development (SSD).

The Department's assessment process requires an Environmental Impact Statement which would include various impact assessments including: Visual, Noise, Aviation, Traffic and Transportation.

Epuron has been developing renewable energy projects since 2003 with a strong track record:

- Australian owned and run, based in North Sydney, NSW
- 4000 megawatts of wind developed in NSW in 8 approved wind farms
- 400 megawatts of solar farm development experience
